ORDER APPROVING APPLICATION OF THE AUTOMOBILE INSURANCE PLANS SERVICE OFFICE ON BEHALF OF LIBERTY MUTUAL INSURANCE COMPANY FOR A SPECIFIC RATE FOR CAPITAL DREAM CARS PURSUANT TO SECTION 47.A.4. STATUTORY ASSIGNMENTS OF THE VIRGINIA AUTOMOBILE INSURANCE PLAN APPENDIX.

BY CORRESPONDENCE RECEIVED May 24, 2007, June 8, 2007, July 13, 2007, July 17, 2007 and July 24, 2007, came the Automobile Insurance Plans Service Office on behalf of Liberty Mutual Insurance Company, and filed with and requested approval of the Commissioner of Insurance of a specific rate, pursuant to Section 47.A.4 Statutory Assignments of the Virginia Automobile Insurance Plan Appendix.

AND IT APPEARING from an examination made by the staff of the Bureau of Insurance, and from representations made by the Automobile Insurance Plans Service Office on behalf of Liberty Mutual Insurance Company, that a specific rate is required;

IT IS, THEREFORE, ORDERED:

- (1) That the application of the Automobile Insurance Plans Service Office on behalf of Liberty Mutual Insurance Company, for a specific premium of \$4,992 for comprehensive with a \$1000 deductible and \$4,602 for collision with a \$1000 deductible on a 2004 Lamborghini is approved for the period of April 27, 2007 through February 13, 2008, \$5,588 for comprehensive with a \$1000 deductible and \$5,444 for collision with a \$1000 deductible on a 2004 Bentley for the period of February 13, 2007 through February 13, 2008, and \$6,408 for comprehensive with a \$1000 deductible and \$5,832 for collision with a \$1000 deductible on a 2001 Ferrari for the period of February 13, 2007 through February 13, 2008 is approved; and
