The health insurance issuers listed on the following pages have registered with the Virginia State Corporation Commission (SCC), Bureau of Insurance (BOI) as Small Employer Carriers. These health insurance issuers have received approval from the BOI as *Standard and Essential Health Benefit Plans*. In accordance with Virginia Law, the Standard and Essential Health Benefit Plans must be offered to Small Employers in Virginia.

It should be noted that an issuer may not sell a health benefit plan to a Small Employer in Virginia, unless the issuer's name appears on the list.
