The Office of the Clerk serves as the central filing office for all Virginia and foreign corporations, limited liability companies, general and limited partnerships, and business trusts that are authorized to transact business in Virginia (to obtain information about a sole proprietorship, contact the locality where the business is conducted).

The Clerk's Office also serves as the central location in Virginia for the filing and indexing of Uniform Commercial Code (UCC) financing statements and certain federal tax liens.

Limited Liability Company Assessment of Annual Registration Fees (§13.1-1062)

The SCC has adopted a regulation, effective April 30, 2011, by which limited liability companies (LLC) are assessed annual registration fees based on the anniversary month of their formation (if a Virginia LLC) or registration to transact business in Virginia (if a foreign LLC).

The Commission will mail each company a notice of assessment approximately two months prior to its anniversary month. The annual registration fee payment is due by the last day of the anniversary month of formation or registration.

- A company that fails to pay its annual registration fee by the last day of the anniversary month of formation or registration incurs a \$25 late penalty fee.
- If the registration fee remains unpaid, the company's existence will be automatically cancelled the last day of the third month following the due date of the fee.

The revised schedule for LLCs will result in more efficient handling of the large volume of LLC payments and associated paperwork by the SCC's Clerk's Office. It will also help the office prepare for the addition of online payments for LLCs to its SCC eFile website.
