2. Reference RFP Section V, C.6. (page 96), *Technical Requirements*, 2nd paragraph titled *Standards* is changed to read:

The Contractor shall adhere to technical standards as specified by the SCC. These include, but are not limited to, coding standards, database connection standards, database naming standards, active directory integration standards and the standard for approved technologies and products. ²²

Addendum No. 1 RFP# SCC-12-020-SCC Page **1** of **3** The SCC has methodically and intentionally moved from multiple architectural environments toward a standard enterprise-wide architectural platform, based on .NET and Oracle. It is the SCC's preference to continue that direction. Nonetheless, this RFP does not dictate that the solution proposed by an Offeror operate in a .NET and Oracle environment.

If the proposed solution deviates from the SCC standard architecture, the Offeror shall account for the long-term impact of such a change using the form in Appendix I, Project Requirements Acknowledgement and Traceability. That long-term impact analysis shall include, at a minimum, high-level technical, operational, support and financial assessments associated with an SCC choice to use a different environment to satisfy the business requirements identified in this RFP.

If at any point after contract award, the Contractor's solutions deviate from any technical standards, an impact analysis shall be conducted by project core team members. The impact analysis shall include the technical, operational, support and financial assessments of the proposed change.

3. Reference RFP Section V, C.6, *Documentation*, Table reflected on page 99: Description associated with "TECH 25" has been changed and now reads:

Req#	Title	Description
TECH-25	Adherence to Standards	The Contractor shall adhere to technical standards as specified by the SCC including (but not limited to) coding standards, database connection standards, database naming standards, active directory integration standards and the standard for approved technologies and products. If a Contractor's solution deviates from any SCC technical standards, an impact analysis shall be conducted by project core team members. The impact analysis shall include the technical, operational, support and financial assessments of the proposed change.

4. Reference RFP Section XIII, *Method of Payment*, page 122, has been changed to <u>delete</u> the 3rd paragraph and now reads:

METHOD OF PAYMENT

Payment will be made in accordance with Paragraph J of the General Terms and Conditions.

The Contractor shall submit an invoice to the SCC for accepted and approved deliverables. Supporting documentation detailing the associated contract fees and written acceptance of the deliverable for each invoice shall be provided by the Contractor to the SCC.
