OBSERVATION REPORT #12

KPMG Consulting received unexpected errors from Verizon representatives when submitting Local Service Requests (LSRs) under the LSOG 4.5.1 Business Rules.

Issue

In May 2001, KPMG Consulting submitted LSRs for Resale, UNE-Platform, and UNE-Loop products using the LSOG 4.5.1 Business Rules. In multiple instances, Verizon representatives responded with error messages that appear to contradict Verizon's business rules (see Exhibit 1).

In each instance, KPMG Consulting contacted the Verizon National Market Center (VNMC) to dispute the errors and a VNMC representative recanted the query. The VNMC then issued a Local Response (LSRLR) or requested that KPMG Consulting send a Supplemental LSR (SUP) identical to the initial order to complete the order transaction.
