## OBSERVATION REPORT #28

KPMG Consulting observed incomplete metric results in the Verizon Virginia May and June 2001 Aggregate Carrier-to-Carrier (C2C) reports.

### Issue

The *Virginia Carrier-to-Carrier Guidelines Performance Standards and Reports* of August 11, 2000<sup>1</sup> define the metrics against which Verizon Virginia must report their monthly performance. However, KPMG Consulting observed that Verizon is not reporting all metrics as required by the Virginia State Corporation Commission.

Exhibit 1 identifies individual metrics for which KPMG Consulting found no metric results on the May and June 2001 C2C reports.
