OBSERVATION REPORT #51

KPMG Consulting has observed that Verizon sent both Jeopardy notifications (JEOP) and additional Local Service Request Local Responses (LSRLR) to originally confirmed orders.

Issue

According to Verizon's *Jeopardy Notification Document*, ¹ a CLEC should receive a JEOP if the confirmed Due Date (DD) on the LSRLR will not be met. Otherwise, it is KPMG Consulting's understanding of the LSOG 4.7.1 Order Business Rules that a CLEC should receive only one LSRLR confirming the DD.

Through November 9, 2001, KPMG Consulting submitted 1334 Local Service Requests (LSR), each receiving one LSRLR with a DD. However, after receiving the LSRLR, KPMG Consulting then received both an additional LSRLR and a JEOP for 17 of these orders.

Exhibit 1 lists the PONs for which KPMG Consulting has received both JEOPs and additional LSRLRs.
