OBSERVATION REPORT #63

KPMG Consulting observed that Verizon did not populate Conversational TN Selection Responses (AD2) according to the LSOG 4.7.1 Pre-Order Business Rules.

<u>Issue</u>

According to the LSOG 4.7.1 Pre-Order Business Rules, the population of the Foreign Exchange (FX) field, see Exhibit 1, is required for all AD2s.

In October and November 2001, KPMG Consulting submitted 31 Conversational TN Selection Inquiry pre-orders (ADI) as part of the Conversational TN selection process. However, KPMG Consulting observed that the FX field was not populated for all AD2s received.
