Dear Ms. Larsen and Mr. Stephens:

On January 26, 2011, the Dominion Virginia Power submitted a verification that it had met the 2010 REPS Goal I. After the submission, the Company discovered that Attachment 1, on the column titled "Energy Generated during 2010," shows megawatts hours (MWh) calculated at 100% of the Virginia Electric and Power Company system and did not show the Virginia jurisdictional factor (which is 80.69%). Attached is a Revised Attachment 1, which provides the Virginia jurisdictional amounts of renewable energy generated, RECs optimized and RECs purchased for compliance in 2010. The total requirement is 1,732,746 MWh for 2010 RPS Goal I compliance remains the same and the Company applied its jurisdictional renewable energy, RECs optimized and RECs purchased to meet the 2010 RPS Goal I as stated in Revised Attachment 1.




